## SOLUTIONS TO CONCEPTS

## CHAPTER - 10

1. $\omega_{0}=0 ; \rho=100 \mathrm{rev} / \mathrm{s} ; \omega=2 \pi ; \rho=200 \pi \mathrm{rad} / \mathrm{s}$
$\Rightarrow \omega=\omega_{0}=\alpha t$
$\Rightarrow \omega=\alpha t$
$\Rightarrow \alpha=(200 \pi) / 4=50 \pi \mathrm{rad} / \mathrm{s}^{2}$ or $25 \mathrm{rev} / \mathrm{s}^{2}$
$\therefore \theta=\omega_{0} \mathrm{t}+1 / 2 \alpha \mathrm{t}^{2}=8 \times 50 \pi=400 \pi \mathrm{rad}$
$\therefore \alpha=50 \pi \mathrm{rad} / \mathrm{s}^{2}$ or $25 \mathrm{rev} / \mathrm{s}^{\mathrm{s}}$
$\theta=400 \pi \mathrm{rad}$.
2. $\theta=100 \pi ; t=5 \mathrm{sec}$
$\theta=1 / 2 \alpha t^{2} \Rightarrow 100 \pi=1 / 2 \alpha 25$
$\Rightarrow \alpha=8 \pi \times 5=40 \pi \mathrm{rad} / \mathrm{s}=20 \mathrm{rev} / \mathrm{s}$
$\therefore \alpha=8 \pi \mathrm{rad} / \mathrm{s}^{2}=4 \mathrm{rev} / \mathrm{s}^{2}$
$\omega=40 \pi \mathrm{rad} / \mathrm{s}^{2}=20 \mathrm{rev} / \mathrm{s}^{2}$.
3. Area under the curve will decide the total angle rotated
$\therefore$ maximum angular velocity $=4 \times 10=40 \mathrm{rad} / \mathrm{s}$
Therefore, area under the curve $=1 / 2 \times 10 \times 40+40 \times 10+1 / 2 \times 40 \times 10$ $=800 \mathrm{rad}$

$\therefore$ Total angle rotated $=800 \mathrm{rad}$.
4. $\alpha=1 \mathrm{rad} / \mathrm{s}^{2}, \omega_{0}=5 \mathrm{rad} / \mathrm{s} ; \omega=15 \mathrm{rad} / \mathrm{s}$
$\therefore \mathrm{w}=\mathrm{w}_{0}+\alpha \mathrm{t}$
$\Rightarrow t=\left(\omega-\omega_{0}\right) / \alpha=(15-5) / 1=10 \mathrm{sec}$
Also, $\theta=\omega_{0} t+1 / 2 \alpha t^{2}$
$=5 \times 10+1 / 2 \times 1 \times 100=100 \mathrm{rad}$.
5. $\quad \theta=5 \mathrm{rev}, \alpha=2 \mathrm{rev} / \mathrm{s}^{2}, \omega_{0}=0 ; \omega=$ ?
$\omega^{2}=(2 \alpha \theta)$
$\Rightarrow \omega=\sqrt{2 \times 2 \times 5}=2 \sqrt{5} \mathrm{rev} / \mathrm{s}$.
or $\theta=10 \pi \mathrm{rad}, \alpha=4 \pi \mathrm{rad} / \mathrm{s}^{2}, \omega_{0}=0, \omega=$ ?
$\omega=\sqrt{2 \alpha \theta}=2 \times 4 \pi \times 10 \pi$
$=4 \pi \sqrt{5} \mathrm{rad} / \mathrm{s}=2 \sqrt{5} \mathrm{rev} / \mathrm{s}$.
6. A disc of radius $=10 \mathrm{~cm}=0.1 \mathrm{~m}$

Angular velocity $=20 \mathrm{rad} / \mathrm{s}$
$\therefore$ Linear velocity on the rim $=\omega r=20 \times 0.1=2 \mathrm{~m} / \mathrm{s}$
$\therefore$ Linear velocity at the middle of radius $=\omega \mathrm{r} / 2=20 \times(0.1) / 2=1 \mathrm{~m} / \mathrm{s}$.
7. $t=1 \mathrm{sec}, \mathrm{r}=1 \mathrm{~cm}=0.01 \mathrm{~m}$
$\alpha=4 \mathrm{rd} / \mathrm{s}^{2}$
Therefore $\omega=\alpha t=4 \mathrm{rad} / \mathrm{s}$
Therefore radial acceleration,
$A_{n}=\omega^{2} r=0.16 \mathrm{~m} / \mathrm{s}^{2}=16 \mathrm{~cm} / \mathrm{s}^{2}$
Therefore tangential acceleration, $a_{r}=\alpha r=0.04 \mathrm{~m} / \mathrm{s}^{2}=4 \mathrm{~cm} / \mathrm{s}^{2}$.
8. The Block is moving the rim of the pulley

The pulley is moving at a $\omega=10 \mathrm{rad} / \mathrm{s}$
Therefore the radius of the pulley $=20 \mathrm{~cm}$
Therefore linear velocity on the rim = tangential velocity $=\mathrm{r} \omega$
$=20 \times 20=200 \mathrm{~cm} / \mathrm{s}=2 \mathrm{~m} / \mathrm{s}$.

9. Therefore, the $\perp$ distance from the axis $(A D)=\sqrt{3} / 2 \times 10=5 \sqrt{3} \mathrm{~cm}$.

Therefore moment of inertia about the axis $B C$ will be
$\mathrm{I}=\mathrm{mr}^{2}=200 \mathrm{~K}(5 \sqrt{3})^{2}=200 \times 25 \times 3$
$=15000 \mathrm{gm}-\mathrm{cm}^{2}=1.5 \times 10^{-3} \mathrm{~kg}-\mathrm{m}^{2}$.
b) The axis of rotation let pass through A and $\perp$ to the plane of triangle Therefore the torque will be produced by mass $B$ and $C$
 Therefore net moment of inertia $=\mathrm{I}=\mathrm{mr}^{2}+\mathrm{mr}^{2}$
$=2 \times 200 \times 10^{2}=40000 \mathrm{gm}-\mathrm{cm}^{2}=4 \times 10^{-3} \mathrm{~kg}-\mathrm{m}^{2}$.
10. Masses of $1 \mathrm{gm}, 2 \mathrm{gm} \ldots . .100 \mathrm{gm}$ are kept at the marks $1 \mathrm{~cm}, 2 \mathrm{~cm}, \ldots . .1000 \mathrm{~cm}$ on he x axis respectively. A perpendicular axis is passed at the $50^{\text {th }}$ particle.
Therefore on the L.H.S. side of the axis there will be 49 particles and on the R.H.S. side there are 50 particles.
Consider the two particles at the position 49 cm and 51 cm .
Moment inertial due to these two particle will be $=$

$$
49 \times 1^{2}+51+1^{2}=100 \mathrm{gm}-\mathrm{cm}^{2}
$$



Similarly if we consider $48^{\text {th }}$ and $52^{\text {nd }}$ term we will get $100 \times 2^{2} \mathrm{gm}-\mathrm{cm}^{2}$
Therefore we will get 49 such set and one lone particle at 100 cm .
Therefore total moment of inertia $=$
1102030405060708090100


$$
100\left\{1^{2}+2^{2}+3^{2}+\ldots+49^{2}\right\}+100(50)^{2}
$$

$=100 \times(50 \times 51 \times 101) / 6=4292500 \mathrm{gm}-\mathrm{cm}^{2}$
$=0.429 \mathrm{~kg}-\mathrm{m}^{2}=0.43 \mathrm{~kg}-\mathrm{m}^{2}$.
11. The two bodies of mass $m$ and radius $r$ are moving along the common tangent. Therefore moment of inertia of the first body about XY tangent.
$=m r^{2}+2 / 5 \mathrm{mr}^{2}$

- Moment of inertia of the second body XY tangent $=m r^{2}+2 / 5 \mathrm{mr}^{2}=7 / 5 \mathrm{mr}^{2}$

Therefore, net moment of inertia $=7 / 5 \mathrm{mr}^{2}+7 / 5 \mathrm{mr}^{2}=14 / 5 \mathrm{mr}^{2}$ units.

12. Length of the rod $=1 \mathrm{~m}$, mass of the rod $=0.5 \mathrm{~kg}$

Let at a distance $d$ from the center the rod is moving
Applying parallel axis theorem :
The moment of inertial about that point
$\Rightarrow\left(\mathrm{mL}^{2} / 12\right)+\mathrm{md}^{2}=0.10$
$\Rightarrow\left(0.5 \times 1^{2}\right) / 12+0.5 \times d^{2}=0.10$
$\Rightarrow d^{2}=0.2-0.082=0.118$

$\Rightarrow d=0.342 \mathrm{~m}$ from the centre.
13. Moment of inertia at the centre and perpendicular to the plane of the ring.

So, about a point on the rim of the ring and the axis $\perp$ to the plane of the ring, the moment of inertia
$=m R^{2}+m R^{2}=2 m R^{2}$ (parallel axis theorem)
$\Rightarrow \mathrm{mK}^{2}=2 \mathrm{mR}^{2}$ ( $\mathrm{K}=$ radius of the gyration)
$\Rightarrow K=\sqrt{2 R^{2}}=\sqrt{2} R$.
14. The moment of inertia about the center and $\perp$ to the plane of the disc of radius $r$ and mass $m$ is $=m r^{2}$.
According to the question the radius of gyration of the disc about a point $=$ radius of the disc.
Therefore $m k^{2}=1 / 2 m r^{2}+m d^{2}$
( $\mathrm{K}=$ radius of gyration about acceleration point, $\mathrm{d}=$ distance of that point
 from the centre)
$\Rightarrow K^{2}=r^{2} / 2+d^{2}$
$\Rightarrow r^{2}=r^{2} / 2+d^{2}(\therefore K=r)$
$\Rightarrow r^{2} / 2=d^{2} \Rightarrow d=r / \sqrt{2}$.
15. Let a small cross sectional area is at a distance $x$ from $x x$ axis.

Therefore mass of that small section $=m / a^{2} \times a x d x$
Therefore moment of inertia about xx axis
$=I_{x x}=2 \int_{0}^{a / 2}\left(m / a^{2}\right) \times(a d x) \times x^{2}=\left(2 \times(m / a)\left(x^{3} / 3\right)\right]_{0}^{a / 2}$
$=m a^{2} / 12$
Therefore $I_{x x}=I_{x x}+I_{y y}$


$$
\left.=2 \times * \mathrm{ma}^{2} / 12\right)=\mathrm{ma}^{2} / 6
$$

Since the two diagonals are $\perp$ to each other
Therefore $I_{z z}=I_{x^{\prime} x^{\prime}}+I_{y^{\prime} y^{\prime}}$
$\Rightarrow \mathrm{ma}^{2} / 6=2 \times I_{x^{\prime} x^{\prime}}\left(\right.$ because $\left.I_{x^{\prime} x^{\prime}}=I_{y^{\prime} y^{\prime}}\right) \Rightarrow I_{x^{\prime} x^{\prime}}=\mathrm{ma}^{2} / 12$
16. The surface density of a circular disc of radius a depends upon the distance from the centre as
$P(r)=A+B r$
Therefore the mass of the ring of radius $r$ will be
$\theta=(A+B r) \times 2 \pi r d r \times r^{2}$
Therefore moment of inertia about the centre will be
$=\int_{0}^{a}(\mathrm{~A}+\mathrm{Br}) 2 \pi \mathrm{r} \times \mathrm{dr}=\int_{0}^{\mathrm{a}} 2 \pi \mathrm{Ar}{ }^{3} \mathrm{dr}+\int_{0}^{\mathrm{a}} 2 \pi \mathrm{Br}^{4} \mathrm{dr}$

$\left.=2 \pi \mathrm{~A}\left(\mathrm{r}^{4} / 4\right)+2 \pi \mathrm{~B}\left(\mathrm{r}^{5} / 5\right)\right]_{0}^{\mathrm{a}}=2 \pi \mathrm{a}^{4}[(\mathrm{~A} / 4)+(\mathrm{Ba} / 5)]$.
17. At the highest point total force acting on the particle id its weight acting downward.

Range of the particle $=u^{2} \sin 2 \pi / g$
Therefore force is at a $\perp$ distance, $\Rightarrow$ (total range $) / 2=\left(v^{2} \sin 2 \theta\right) / 2 \mathrm{~g}$
(From the initial point)
Therefore $\tau=\mathrm{F} \times \mathrm{r}(\theta=$ angle of projection $)$
$=m g \times v^{2} \sin 2 \theta / 2 g(v=$ initial velocity $)$

$=m v^{2} \sin 2 \theta / 2=m v^{2} \sin \theta \cos \theta$.
18. A simple of pendulum of length $I$ is suspended from a rigid support. $A$ bob of weight $W$ is hanging on the other point.
When the bob is at an angle $\theta$ with the vertical, then total torque acting on the point of suspension $=\mathrm{i}=\mathrm{F} \times \mathrm{r}$
$\Rightarrow \mathrm{Wr} \sin \theta=\mathrm{W} \mathrm{I} \sin \theta$


At the lowest point of suspension the torque will be zero as the force acting on the body passes through the point of suspension.
19. A force of 6 N acting at an angle of $30^{\circ}$ is just able to loosen the wrench at a distance 8 cm from it. Therefore total torque acting at A about the point 0
$=6 \sin 30^{\circ} \times(8 / 100)$
Therefore total torque required at $B$ about the point 0
$=F \times 16 / 100 \Rightarrow F \times 16 / 100=6 \sin 30^{\circ} \times 8 / 100$
$\Rightarrow F=(8 \times 3) / 16=1.5 \mathrm{~N}$.
20. Torque about a point $=$ Total force $\times$ perpendicular distance from the point to that force.

Let anticlockwise torque $=+$ ve
And clockwise acting torque $=-$ ve
Force acting at the point B is 15 N
Therefore torque at O due to this force
$=15 \times 6 \times 10^{-2} \times \sin 37^{\circ}$
$=15 \times 6 \times 10^{-2} \times 3 / 5=0.54 \mathrm{~N}-\mathrm{m}$ (anticlock wise)
Force acting at the point C is 10 N
Therefore, torque at O due to this force
$=10 \times 4 \times 10^{-2}=0.4 \mathrm{~N}-\mathrm{m}$ (clockwise)


Force acting at the point A is 20 N
Therefore, Torque at O due to this force $=20 \times 4 \times 10^{-2} \times \sin 30^{\circ}$
$=20 \times 4 \times 10^{-2} \times 1 / 2=0.4 \mathrm{~N}-\mathrm{m}$ (anticlockwise)
Therefore resultant torque acting at ' O ' $=0.54-0.4+0.4=0.54 \mathrm{~N}-\mathrm{m}$.
21. The force mg acting on the body has two components $\mathrm{mg} \sin \theta$ and $\mathrm{mg} \cos \theta$ and the body will exert a normal reaction. Let $\mathrm{R}=$
Since $R$ and $m g \cos \theta$ pass through the centre of the cube, there will be no torque
 due to $R$ and $\mathrm{mg} \cos \theta$. The only torque will be produced by $\mathrm{mg} \sin \theta$.

$\therefore \mathrm{i}=\mathrm{F} \times \mathrm{r}(\mathrm{r}=\mathrm{a} / 2) \quad(\mathrm{a}=$ ages of the cube $)$
$\Rightarrow \mathrm{i}=\mathrm{mg} \sin \theta \times \mathrm{a} / 2$
$=1 / 2 \mathrm{mg}$ a $\sin \theta$.
22. A rod of mass $m$ and length $L$, lying horizontally, is free to rotate about a vertical axis passing through its centre.
A force $F$ is acting perpendicular to the rod at a distance $L / 4$ from the centre.
Therefore torque about the centre due to this force

$$
\mathrm{i}_{\mathrm{i}}=\mathrm{F} \times \mathrm{r}=\mathrm{FL} / 4 .
$$

This torque will produce a angular acceleration $\alpha$.
Therefore $\tau_{c}=I_{c} \times \alpha$
$\Rightarrow \mathrm{i}_{\mathrm{c}}=\left(\mathrm{mL}^{2} / 12\right) \times \alpha\left(\mathrm{I}_{\mathrm{c}}\right.$ of a rod $\left.=\mathrm{mL}^{2} / 12\right)$
$\Rightarrow \mathrm{Fi} / 4=\left(\mathrm{mL}^{2} / 12\right) \times \alpha \Rightarrow \alpha=3 \mathrm{~F} / \mathrm{ml}$
Therefore $\theta=1 / 2 \alpha t^{2}$ (initially at rest)

$\Rightarrow \theta=1 / 2 \times(3 \mathrm{~F} / \mathrm{ml}) \mathrm{t}^{2}=(3 \mathrm{~F} / 2 \mathrm{ml}) \mathrm{t}^{2}$.
23. A square plate of mass 120 gm and edge 5 cm rotates about one of the edge.

Let take a small area of the square of width $d x$ and length a which is at a distance $x$ from the axis of rotation.
Therefore mass of that small area
$\mathrm{m} / \mathrm{a}^{2} \times \mathrm{adx}(\mathrm{m}=$ mass of the square $; \mathrm{a}=$ side of the plate $)$

$\left.I=\int_{0}^{a}\left(m / a^{2}\right) \times \mathrm{ax}^{2} \mathrm{dx}=(\mathrm{m} / \mathrm{a})\left(\mathrm{x}^{3} / 3\right)\right]_{0}^{a}$
$=\mathrm{ma}^{2} / 3$
Therefore torque produced $=1 \times \alpha=\left(\mathrm{ma}^{2} / 3\right) \times \alpha$
$=\left\{\left(120 \times 10^{-3} \times 5^{2} \times 10^{-4}\right) / 3\right\} 0.2$
$=0.2 \times 10^{-4}=2 \times 10^{-5} \mathrm{~N}-\mathrm{m}$.
24. Moment of inertial of a square plate about its diagonal is $\mathrm{ma}^{2} / 12$ ( $\mathrm{m}=$ mass of the square plate)

$$
\mathrm{a}=\text { edges of the square }
$$

Therefore torque produced $=\left(\mathrm{ma}^{2} / 12\right) \times \alpha$
$=\left\{\left(120 \times 10^{-3} \times 5^{2} \times 10^{-4}\right) / 12 \times 0.2\right.$
$=0.5 \times 10^{-5} \mathrm{~N}-\mathrm{m}$.
25. A flywheel of moment of inertia 5 kg m is rotated at a speed of $60 \mathrm{rad} / \mathrm{s}$. The flywheel comes to rest due to the friction at the axle after 5 minutes.
Therefore, the angular deceleration produced due to frictional force $=\omega=\omega_{0}+\alpha t$
$\Rightarrow \omega_{0}=-\alpha \mathrm{t}(\omega=0+$
$\Rightarrow \alpha=-(60 / 5 \times 60)=-1 / 5 \mathrm{rad} / \mathrm{s}^{2}$.
a) Therefore total workdone in stopping the wheel by frictional force
$\mathrm{W}=1 / 2 \mathrm{i} \omega^{2}=1 / 2 \times 5 \times(60 \times 60)=9000 \mathrm{Joule}=9 \mathrm{KJ}$.
b) Therefore torque produced by the frictional force (R) is
 $I_{R}=I \times \alpha=5 \times(-1 / 5)=I N-m$ opposite to the rotation of wheel.
c) Angular velocity after 4 minutes
$\Rightarrow \omega=\omega_{0}+\alpha t=60-240 / 5=12 \mathrm{rad} / \mathrm{s}$
Therefore angular momentum about the centre $=1 \times \omega=5 \times 12=60 \mathrm{~kg}-\mathrm{m}^{2} / \mathrm{s}$.
26. The earth's angular speed decreases by $0.0016 \mathrm{rad} / \mathrm{day}$ in 100 years.

Therefore the torque produced by the ocean water in decreasing earth's angular velocity

$$
\begin{aligned}
& \tau=\mathrm{l} \alpha \\
& =2 / 5 \mathrm{mr}^{2} \times\left(\omega-\omega_{0}\right) / \mathrm{t} \\
& =2 / 6 \times 6 \times 10^{24} \times 64^{2} \times 10^{10} \times\left[0.0016 /\left(26400^{2} \times 100 \times 365\right)\right](1 \text { year }=365 \text { days }=365 \times 56400 \mathrm{sec}) \\
& =5.678 \times 10^{20} \mathrm{~N}-\mathrm{m} .
\end{aligned}
$$

27. A wheel rotating at a speed of 600 rpm .
$\omega_{0}=600 \mathrm{rpm}=10$ revolutions per second.
$T=10 \mathrm{sec}$. (In 10 sec . it comes to rest)
$\omega=0$
Therefore $\omega_{0}=-\alpha \mathrm{t}$
$\Rightarrow \alpha=-10 / 10=-1 \mathrm{rev} / \mathrm{s}^{2}$
$\Rightarrow \omega=\omega_{0}+\alpha t=10-1 \times 5=5 \mathrm{rev} / \mathrm{s}$.
Therefore angular deacceleration $=1 \mathrm{rev} / \mathrm{s}^{2}$ and angular velocity of after 5 sec is $5 \mathrm{rev} / \mathrm{s}$.
28. $\omega=100 \mathrm{rev} / \mathrm{min}=5 / 8 \mathrm{rev} / \mathrm{s}=10 \pi / 3 \mathrm{rad} / \mathrm{s}$
$\theta=10 \mathrm{rev}=20 \pi \mathrm{rad}, \mathrm{r}=0.2 \mathrm{~m}$
After 10 revolutions the wheel will come to rest by a tangential force
Therefore the angular deacceleration produced by the force $=\alpha=\omega^{2} / 2 \theta$
Therefore the torque by which the wheel will come to an rest $=I_{c m} \times \alpha$
$\Rightarrow \mathrm{F} \times \mathrm{r}=\mathrm{I}_{\mathrm{cm}} \times \alpha \rightarrow \mathrm{F} \times 0.2=1 / 2 \mathrm{mr}^{2} \times\left[(10 \pi / 3)^{2} /(2 \times 20 \pi)\right]$
$\Rightarrow F=1 / 2 \times 10 \times 0.2 \times 100 \pi^{2} /(9 \times 2 \times 20 \pi)$

$$
=5 \pi / 18=15.7 / 18=0.87 \mathrm{~N}
$$

29. A cylinder is moving with an angular velocity $50 \mathrm{rev} / \mathrm{s}$ brought in contact with another identical cylinder in rest. The first and second cylinder has common acceleration and deacceleration as $1 \mathrm{rad} / \mathrm{s}^{2}$ respectively.
Let after t sec their angular velocity will be same ' $\omega$ '.
For the first cylinder $\omega=50-\alpha t$
$\Rightarrow t=(\omega-50) /-1$
And for the $2^{\text {nd }}$ cylinder $\omega=\alpha_{2} \mathrm{t}$
$\Rightarrow t=\omega / l$


So, $\omega=(\omega-50) /-1$
$\Rightarrow 2 \omega=50 \Rightarrow \omega=25 \mathrm{rev} / \mathrm{s}$.
$\Rightarrow t=25 / 1 \mathrm{sec}=25 \mathrm{sec}$.
30. Initial angular velocity $=20 \mathrm{rad} / \mathrm{s}$

Therefore $\alpha=2 \mathrm{rad} / \mathrm{s}^{2}$
$\Rightarrow \mathrm{t}_{1}=\omega / \alpha_{1}=20 / 2=10 \mathrm{sec}$
Therefore 10 sec it will come to rest.
Since the same torque is continues to act on the body it will produce same angular acceleration and since the initial kinetic energy $=$ the kinetic energy at a instant.
So initial angular velocity = angular velocity at that instant
Therefore time require to come to that angular velocity,
$\mathrm{t}_{2}=\omega_{2} / \alpha_{2}=20 / 2=10 \mathrm{sec}$
therefore time required $=t_{1}+t_{2}=20 \mathrm{sec}$.
31. $I_{\text {net }}=I_{\text {net }} \times \alpha$
$\Rightarrow F_{1} r_{1}-F_{2} r_{2}=\left(m_{1} r_{1}^{2}+m_{2} r_{2}^{2}\right) \times \alpha-2 \times 10 \times 0.5$
$\Rightarrow 5 \times 10 \times 0.5=\left(5 \times(1 / 2)^{2}+2 \times(1 / 2)^{2}\right) \times \alpha$
$\Rightarrow 15=7 / 4 \alpha$

$\Rightarrow \alpha=60 / 7=8.57 \mathrm{rad} / \mathrm{s}^{2}$.
32. In this problem the rod has a mass 1 kg
a) $\tau_{\text {net }}=I_{\text {net }} \times \alpha$

$$
\begin{aligned}
& \Rightarrow 5 \times 10 \times 10.5-2 \times 10 \times 0.5 \\
& =\left(5 \times(1 / 2)^{2}+2 \times(1 / 2)^{2}+1 / 12\right) \times \alpha
\end{aligned}
$$



$$
\begin{aligned}

$h=\frac{2 R}{3}$
81. A uniform wheel of radius $R$ is set into rotation about its axis (case-I) at an angular speed $\omega$ This rotating wheel is now placed on a rough horizontal. Because of its friction at contact, the wheel accelerates forward and its rotation decelerates. As the rotation decelerates the frictional force will act backward.
If we consider the net moment at $A$ then it is zero.
Therefore the net angular momentum before pure rolling \& after pure rolling remains constant
Before rolling the wheel was only rotating around its axis.
Therefore Angular momentum $=\ell \omega=(1 / 2) \mathrm{MR}^{2} \omega \ldots(1)$


After pure rolling the velocity of the wheel let $v$
Therefore angular momentum $=\ell_{\mathrm{cm}} \omega+\mathrm{m}(\mathrm{V} \times \mathrm{R})$
$=(1 / 2) m R^{2}(V / R)+m V R=3 / 2 m V R$
Because, $\mathrm{Eq}(1)$ and (2) are equal
Therefore, $3 / 2 \mathrm{mVR}=1 / 2 \mathrm{mR}^{2} \omega$

$\Rightarrow V=\omega R / 3$
82. The shell will move with a velocity nearly equal to $v$ due to this motion a frictional force well act in the background direction, for which after some time the shell attains a pure rolling. If we consider moment about A, then it will be zero. Therefore, Net angular momentum about A before pure rolling $=$ net angular momentum after pure rolling.
Now, angular momentum before pure rolling about $A=M(V \times R)$ and angular momentum after pure rolling :-

$(2 / 3) M R^{2} \times\left(V_{0} / R\right)+M V_{0} R$
( $\mathrm{V}_{0}=$ velocity after pure rolling)
$\Rightarrow M V R=2 / 3 M V_{0} R+M V_{0} R$

$\Rightarrow V_{0}=3 \mathrm{~V} / 5$

$\Rightarrow \alpha=\frac{3 \mathrm{~F}}{2 \mathrm{MR}}$
Again, $2 \pi=(1 / 2) \alpha t^{2}\left(\right.$ From $\left.\theta=\omega_{0} t+(1 / 2) \alpha t^{2}\right)$

$\Rightarrow \mathrm{t}^{2}=\frac{8 \pi \mathrm{MR}}{3 \mathrm{~F}}$
$\Rightarrow a_{c}=\frac{F}{m}$
$\Rightarrow X=(1 / 2) a_{c} t^{2}=(1 / 2)=\frac{4 \pi R}{3}$
84. If we take moment about the centre, then
$F \times R=\ell \alpha \times f \times R$
$\Rightarrow F=2 / 5 \mathrm{mR} \alpha+\mu \mathrm{mg}$
Again, $F=m a_{c}-\mu \mathrm{mg}$
$\Rightarrow \mathrm{a}_{\mathrm{c}}=\frac{\mathrm{F}+\mu \mathrm{mg}}{\mathrm{m}}$


Putting the value $a_{c}$ in eq(1) we get
$\Rightarrow \frac{2}{5} \times \mathrm{m} \times\left(\frac{\mathrm{F}+\mu \mathrm{mg}}{\mathrm{m}}\right)+\mu \mathrm{mg}$

85. a) if we take moment at $A$ then external torque will be zero

Therefore, the initial angular momentum = the angular momentum after rotation stops (i.e. only leniar velocity exits)
$M V \times R-\ell \omega=M V_{0} \times R$
$\Rightarrow M V R-2 / 5 \times M R^{2} V / R=M V_{O} R$
$\Rightarrow V_{0}=3 \mathrm{~V} / 5$

b) Again, after some time pure rolling starts
therefore $\Rightarrow M \times v_{0} \times R=(2 / 5) M R^{2} \times\left(V^{\prime} / R\right)+M V^{\prime} R$
$\Rightarrow \mathrm{m} \times(3 \mathrm{~V} / 5) \times \mathrm{R}=(2 / 5) \mathrm{MV}^{\prime} \mathrm{R}+\mathrm{MV} \mathrm{V}^{\prime} \mathrm{R}$
$\Rightarrow \mathrm{V}^{\prime}=3 \mathrm{~V} / 7$
86. When the solid sphere collides with the wall, it rebounds with velocity ' $v$ ' towards left but it continues to rotate in the clockwise direction.
So, the angular momentum $=m v R-(2 / 5) m R^{2} \times v / R$
After rebounding, when pure rolling starts let the velocity be $\mathrm{v}^{\prime}$
and the corresponding angular velocity is $v^{\prime} / R$
Therefore angular momentum $=m v^{\prime} R+(2 / 5) m R^{2}\left(v^{\prime} / R\right)$


So, $m v R-(2 / 5) m R^{2}, v / R=m v R+(2 / 5) m R^{2}\left(v^{\prime} / R\right)$
$\operatorname{mvR} \times(3 / 5)=\operatorname{mvR} \times(7 / 5)$
$\mathrm{v}^{\prime}=3 \mathrm{v} / 7$
So, the sphere will move with velocity $3 \mathrm{v} / 7$.
