$\mathrm{u}=6 \mathrm{~km} / \mathrm{h}=1.666 \mathrm{~m} / \mathrm{sec}$

$\mathrm{v}=12 \mathrm{~km} / \mathrm{h}=3.333 \mathrm{~m} / \mathrm{sec}$
Increase in K.E. $=1 / 2 \mathrm{Mv}^{2}-1 / 2 \mathrm{Mu}^{2}$
$=1 / 290 \times(3.333)^{2}-1 / 2 \times 90 \times(1.66)^{2}=494.5-124.6=374.8 \approx 375 \mathrm{~J}$
2. $m_{b}=2 \mathrm{~kg}$.
$\mathrm{u}=10 \mathrm{~m} / \mathrm{sec}$
$\mathrm{a}=3 \mathrm{~m} / \mathrm{aec}^{2}$
$\mathrm{t}=5 \mathrm{sec}$
$v=u+a t=10+315=25 \mathrm{~m} / \mathrm{sec}$.
$\therefore F . K . E=1 / 2 \mathrm{mv}^{2}=1 / 2 \times 2 \times 625=625 \mathrm{~J}$.
3. $F=100 \mathrm{~N}$
$S=4 \mathrm{~m}, \theta=0^{\circ}$
$\omega=\vec{F} . \vec{S}=100 \times 4=400 \mathrm{~J}$

4. $m=5 \mathrm{~kg}$
$\theta=30^{\circ}$
$\mathrm{S}=10 \mathrm{~m}$
$\mathrm{F}=\mathrm{mg}$


So, work done by the force of gravity
$\omega=\mathrm{mgh}=5 \times 9.8 \times 5=245 \mathrm{~J}$
5. $\mathrm{F}=2.50 \mathrm{~N}, \mathrm{~S}=2.5 \mathrm{~m}, \mathrm{~m}=15 \mathrm{~g}=0.015 \mathrm{~kg}$.

So, $w=F \times S \Rightarrow a=\frac{F}{m}=\frac{2.5}{0.015}=\frac{500}{3} \mathrm{~m} / \mathrm{s}^{2}$

$=\mathrm{F} \times \mathrm{S} \cos 0^{\circ}$ (acting along the same line)

So, work done by this force during this force during the displacement $x=0$ and $x=d$ is given by
$W=\int_{0}^{d} F d x=\int_{0}^{d}(a+b x) d x=a x+\left(b x^{2} / 2\right)=[a+1 / 2 b d] d$

Frictional force $f=\mu R$
$m g \sin \theta=\mu R$
$\mathrm{mg} \cos \theta$
so, work done against $\mu R=\mu R S \cos 0^{\circ}=m g \sin \theta S=0.250 \times 9.8 \times 0.60 \times 1=1.5 \mathrm{~J}$

$\Rightarrow \mu=\frac{\mathrm{ma}}{\mathrm{R}_{1}}=\frac{\mathrm{F}}{2(\mathrm{M}+\mathrm{m}) \mathrm{g}}$
b) Frictional force acting on the smaller block $f=\mu R=\frac{F}{2(M+m) g} \times m g=\frac{m \times F}{2(M+m)}$

c) Work done $w=f s \quad s=d$

$a=\frac{v^{2}-u^{2}}{2 s}=\frac{400}{50}=8 \mathrm{~m} / \mathrm{sec}^{2}$

force needed to accelerate the car $\mathrm{F}=\mathrm{ma}=500 \times 8=4000 \mathrm{~N}$

15. Given, $v=a \sqrt{x}$ (uniformly accelerated motion)
displacement $\mathrm{s}=\mathrm{d}-0=\mathrm{d}$
putting $x=0, \quad v_{1}=0$
putting $x=d, \quad v_{2}=a \sqrt{d}$
$\mathrm{a}=\frac{\mathrm{v}_{2}{ }^{2}-\mathrm{u}_{2}{ }^{2}}{2 \mathrm{~s}}=\frac{\mathrm{a}^{2} \mathrm{~d}}{2 \mathrm{~d}}=\frac{\mathrm{a}^{2}}{2}$
force $f=m a=\frac{m a^{2}}{2}$
work done $w=F S \cos \theta=\frac{m a^{2}}{2} \times d=\frac{m a^{2} d}{2}$

From the free body diagram
$\mathrm{F}=(2 \mathrm{~g} \sin \theta)+\mathrm{ma} \Rightarrow \mathrm{a}=(20-20 \sin \theta) / \mathrm{s}=4 \mathrm{~m} / \mathrm{sec}^{2}$
$S=u t+1 / 2 a t^{2} \quad(u=0, t=1 s, a=1.66)$
$=2 \mathrm{~m}$


So, work, done w = Fs = $20 \times 2=40 \mathrm{~J}$

So, work done by the weight $\mathrm{W}=\mathrm{mgh}=2 \times 10 \times 3=60 \mathrm{~J}$
c) So, frictional force $f=m g \sin \theta$
work done by the frictional forces $w=f s \cos 0^{\circ}=(m g \sin \theta) s=20 \times 0.60 \times 5=60 \mathrm{~J}$
18. Given, $\mathrm{m}=25 \mathrm{og}=0.250 \mathrm{~kg}$,
$u=40 \mathrm{~cm} / \mathrm{sec}=0.4 \mathrm{~m} / \mathrm{sec}$

$\mathrm{S}=\frac{\mathrm{v}^{2}-\mathrm{u}^{2}}{2 \mathrm{a}}=0.082 \mathrm{~m}=8.2 \mathrm{~cm}$
Again, work done against friction is given by
$-\mathrm{w}=\mu \mathrm{RS} \cos \theta$

$\mathrm{V}_{\mathrm{m}}=60 \mathrm{~km} / \mathrm{h}=50 / 3 \mathrm{~m} / \mathrm{sec} \quad \mathrm{t}_{\mathrm{m}}=5 \mathrm{sec}$
So, the maximum acceleration that can be produced is given by,
$a=\frac{(50 / 3)-0}{5}=\frac{10}{3}$
So, the driving force is given by
$\mathrm{F}=\mathrm{ma}=95 \times \frac{10}{3}=\frac{950}{3} \mathrm{~N}$
So, the velocity that can be attained by maximum h.p. white supplying $\frac{950}{3}$ will be
$v=\frac{\mathrm{p}}{\mathrm{F}} \Rightarrow \mathrm{v}=\frac{3.5 \times 746 \times 5}{950}=8.2 \mathrm{~m} / \mathrm{sec}$.
Because, the scooter can reach a maximum of $8.5 \mathrm{~m} / \mathrm{sec}$ while producing a force of $950 / 3 \mathrm{~N}$, the specifications given are some what over claimed.

$\mathrm{a}=\frac{(\mathrm{v} 2 \mathrm{u} 2)}{2 \mathrm{~s}}=\frac{0.16}{0.4}=0.04 \mathrm{~m} / \mathrm{sec}^{2}$


So, work done $W=F s \cos \theta=m(a-g) s \cos \theta$
$\Rightarrow W=30(0.04-9.8) \times 2 \Rightarrow W=-585.5 \Rightarrow W=-586 \mathrm{~J}$.
So, $W=-586 \mathrm{~J}$

From, Equation (i) \& (ii) $T=4 \mathrm{ma} \Rightarrow \mathrm{a}=\frac{\mathrm{T}}{4 \mathrm{~m}} \Rightarrow A=\frac{16}{4 \mathrm{~m}}=\frac{4}{\mathrm{~m}} \mathrm{~m} / \mathrm{s}^{2}$.
Now, $S=u t+1 / 2$ at $^{2}$

$$
\Rightarrow S=\frac{1}{2} \times \frac{4}{\mathrm{~m}} \times 1 \Rightarrow \mathrm{~S}=\frac{2}{\mathrm{~m}} \mathrm{~m}[\text { because } \mathrm{u}=0]

$T-3 g+3 a=0$

Equation (i) \& (ii), we get $3 g-3 a=2 g+2 a \Rightarrow a=\frac{g}{5} \mathrm{~m} / \mathrm{sec}^{2}$
Distance travelled in $4^{\text {th }}$ sec is given by
$S_{4 \text { th }}=\frac{a}{2}(2 n-1)=\frac{\left(\frac{g}{5}\right)}{\mathrm{s}}(2 \times 4-1)=\frac{7 \mathrm{~g}}{10}=\frac{7 \times 9.8}{10} \mathrm{~m}$

59. Let the velocity be $v$ when the body leaves the surface.

From the freebody diagram,
$\frac{m v^{2}}{R}=m g \cos \theta$ [Because normal reaction]
$v^{2}=R g \cos \theta$
Again, form work-energy principle,
Change in K.E. = work done
$\Rightarrow 1 / 2 \mathrm{mv}^{2}-0=\mathrm{mg}(\mathrm{R}-\mathrm{R} \cos \theta)$
$\Rightarrow \mathrm{v}^{2}=2 \mathrm{gR}(1-\cos \theta)$


From (1) and (2)
$\mathrm{Rg} \cos \theta=2 \mathrm{gR}(1-\cos \theta)$
$3 g R \cos \theta=2 g R$
$\operatorname{Cos} \theta=2 / 3$
$\theta=\cos ^{-1}(2 / 3)$
60. a) When the particle is released from rest (fig-1), the centrifugal force is zero.
$N$ force is zero $=m g \cos \theta$
$=\mathrm{mg} \cos 30^{\circ}=\frac{\sqrt{3} \mathrm{mg}}{2}$
b) When the particle leaves contact with the surface (fig-2), $\mathrm{N}=0$.

So, $\frac{m v^{2}}{R} m g \cos \theta$
$\Rightarrow v^{2}=R g \cos \theta$
Again, $1 / 2 m v^{2}=m g R\left(\cos 30^{\circ}-\cos \theta\right)$
$\Rightarrow \mathrm{v}^{2}=2 \operatorname{Rg}\left(\frac{\sqrt{3}}{2}-\cos \theta\right)$..
From equn. (1) and equn. (2)

$R g \cos \theta=\sqrt{3} R g-2 R g \cos \theta$
$\Rightarrow 3 \cos \theta=\sqrt{3}$
$\Rightarrow \cos \theta=\frac{1}{\sqrt{3}} \Rightarrow \theta=\cos ^{-1}\left(\frac{1}{\sqrt{3}}\right)$
So, the distance travelled by the particle before leaving contact,
$\ell=\mathrm{R}(\theta-\pi / 6)$ [because $30^{\circ}=\pi / 6$ ]
putting the value of $\theta$, we get $l=0.43 R$
61. a) Radius $=R$
horizontal speed $=v$
From the free body diagram, (fig-1)
$N=$ Normal force $=m g-\frac{m v^{2}}{R}$

b) When the particle is given maximum velocity so that the centrifugal force Fig-2 Dalances the weight, the particle does not slip on the sphere.
$\frac{m v^{2}}{R}=m g \Rightarrow v=\sqrt{g R}$
c) If the body is given velocity $\mathrm{v}_{1}$
$v_{1}=\sqrt{g R} / 2$
$v_{1}{ }^{2}-g R / 4$
Let the velocity be $\mathrm{v}_{2}$ when it leaves contact with the surface, (fig-2)
So, $\frac{m v^{2}}{R}=m g \cos \theta$
$\Rightarrow \mathrm{v}_{2}{ }^{2}=\mathrm{Rg} \cos \theta$
Again, $1 / 2 \mathrm{mv}_{2}{ }^{2}-1 / 2 \mathrm{mv}_{1}{ }^{2}=\operatorname{mgR}(1-\cos \theta)$
$\Rightarrow \mathrm{v}_{2}{ }^{2}=\mathrm{v}_{1}{ }^{2}+2 \mathrm{gR}(1-\cos \theta)$
From equn. (1) and equn (2)
$R g \cos \theta=(R g / 4)+2 g R(1-\cos \theta)$
$\Rightarrow \cos \theta=(1 / 4)+2-2 \cos \theta$
$\Rightarrow 3 \cos \theta=9 / 4$
$\Rightarrow \cos \theta=3 / 4$
$\Rightarrow \theta=\cos ^{-1}(3 / 4)$
62. a) Net force on the particle between $A \& B, F=m g \sin \theta$
work done to reach $B, W=F S=m g \sin \theta \ell$
Again, work done to reach $B$ to $C=m g h=m g R(1-\cos \theta)$
So, Total workdone $=m g[\ell \sin \theta+R(1-\cos \theta)]$


Now, change in K.E. $=$ work done
$\Rightarrow 1 / 2 \mathrm{mv}_{\mathrm{o}}{ }^{2}=\mathrm{mg}[\ell \sin \theta+\mathrm{R}(1-\cos \theta)$
$\Rightarrow \mathrm{v}_{\mathrm{o}}=\sqrt{2 g(R(1-\cos \theta)+\ell \sin \theta)}$
b) When the block is projected at a speed $2 v_{o}$.

Let the velocity at C will be $\mathrm{V}_{\mathrm{c}}$.
Applying energy principle,
$1 / 2 m v_{c}{ }^{2}-1 / 2 m\left(2 v_{o}\right)^{2}=-m g[\ell \sin \theta+R(1-\cos \theta)]$
$\Rightarrow \mathrm{v}_{\mathrm{c}}{ }^{2}=4 \mathrm{v}_{\mathrm{o}}-2 \mathrm{~g}[\ell \sin \theta+\mathrm{R}(1-\cos \theta)]$
$4.2 \mathrm{~g}[\ell \sin \theta+R(1-\cos \theta)]-2 g[\ell \sin \theta+R(1-\cos \theta)$
$=6 \mathrm{~g}[\ell \sin \theta+\mathrm{R}(1-\cos \theta)]$
So, force acting on the body,
$\Rightarrow N=\frac{m v_{c}{ }^{2}}{R}=6 m g[(l / R) \sin \theta+1-\cos \theta]$

c) Let the block loose contact after making an angle $\theta$
$\frac{m v^{2}}{R}=m g \cos \theta \Rightarrow v^{2}=R g \cos \theta \ldots$. (1)
Again, $1 / 2 \mathrm{mv}^{2}=\mathrm{mg}(\mathrm{R}-\mathrm{R} \cos \theta) \Rightarrow \mathrm{v}^{2}=2 \mathrm{gR}(1-\cos \theta)$
From (1) and (2) $\cos \theta=2 / 3 \Rightarrow \theta=\cos ^{-1}(2 / 3)$
63. Let us consider a small element which makes angle ' $d \theta$ ' at the centre.
$\therefore \mathrm{dm}=(\mathrm{m} / \mathrm{l}) \mathrm{Rd} \theta$
a) Gravitational potential energy of ' dm ' with respect to centre of the sphere $=(\mathrm{dm}) \mathrm{gR} \cos \theta$
$=(\mathrm{mg} / \mathrm{l}) \mathrm{R} \cos \theta \mathrm{d} \theta$


So, Total G.P.E. $=\int_{0}^{\ell / r} \frac{m g R^{2}}{\ell} \cos \theta d \theta \quad[\alpha=(\ell / R)]$ (angle subtended by the chain at the centre).

$$
=\frac{\mathrm{mR}^{2} g}{\ell}[\sin \theta](\ell / R)=\frac{m R g}{\ell} \sin (\ell / R)
$$

b) When the chain is released from rest and slides down through an angle $\theta$, the K.E. of the chain is given
K.E. = Change in potential energy.
$=\frac{m R^{2} g}{\ell} \sin (\ell / R)-m \int \frac{g R^{2}}{\ell} \cos \theta \mathrm{~d} \theta \ldots . . . . . . ?$
$=\frac{m R^{2} g}{\ell}[\sin (\ell / R)+\sin \theta-\sin \{\theta+(\ell / R)\}]$
c) Since, K.E. $=1 / 2 m v^{2}=\frac{m R^{2} g}{\ell}[\sin (\ell / R)+\sin \theta-\sin \{\theta+(\ell / R)\}]$

Taking derivative of both sides with respect to ' t '
$(1 / 2) \times 2 v \times \frac{d v}{d t}=\frac{R^{2} g}{\ell}\left[\cos \theta \times \frac{d \theta}{d t}-\cos (\theta+\ell / R) \frac{d \theta}{d t}\right]$
$\therefore\left(R \frac{d \theta}{d t}\right) \frac{d v}{d t}=\frac{R^{2} g}{\ell} \times \frac{d \theta}{d t}[\cos \theta-\cos (\theta+(\ell / R))]$
When the chain starts sliding down, $\theta=0$.
So, $\frac{\mathrm{dv}}{\mathrm{dt}}=\frac{\mathrm{Rg}}{\ell}[1-\cos (\ell / R)]$
64. Let the sphere move towards left with an acceleration 'a

Let $\mathrm{m}=$ mass of the particle
The particle ' $m$ ' will also experience the inertia due to acceleration ' $a$ ' as it is on the sphere. It will also experience the tangential inertia force ( $\mathrm{m}\left(\mathrm{dv} / \mathrm{dt}\right.$ )) and centrifugal force ( $\mathrm{mv}^{2} / \mathrm{R}$ ).
$m \frac{d v}{d t}=m a \cos \theta+m g \sin \theta \Rightarrow m v \frac{d v}{d t}=m a \cos \theta\left(R \frac{d \theta}{d t}\right)+m g \sin \theta$ $\left(R \frac{d \theta}{d t}\right)$


Because, $v=R \frac{d \theta}{d t}$
$\Rightarrow \mathrm{vd} \mathrm{v}=\mathrm{aR} \cos \theta \mathrm{d} \theta+\mathrm{gR} \sin \theta \mathrm{d} \theta$
Integrating both sides we get,
$\frac{v^{2}}{2}=a R \sin \theta-g R \cos \theta+C$
Given that, at $\theta=0, v=0$, So, $C=g R$
So, $\frac{v^{2}}{2}=a R \sin \theta-g R \cos \theta+g R$

$\therefore \mathrm{v}^{2}=2 \mathrm{R}(\mathrm{a} \sin \theta+\mathrm{g}-\mathrm{g} \cos \theta) \Rightarrow \mathrm{v}=[2 \mathrm{R}(\mathrm{a} \sin \theta+\mathrm{g}-\mathrm{g} \cos \theta)]^{1 / 2}$
